## Eligibility Requirements

The Veterans Administration has established qualification criteria for Veterans and Surviving Spouses applying for the Aid and Attendance Pension benefit, including:

- ★ 90 days or more of active duty, with at least one day of service during a wartime period
- ★ Must have a medical condition which requires assistance with activities of daily living that is not related to military service
- ★ Meet income-to-medical expense ratio
- ★ Must meet asset requirements
